4. Eligibility conditions

The beneficiaries shall be legal entities and be established in one of the two IPA II beneficiary countries participating in the CBC programme.

In line with the programme document, the following main categories are proposed as potential target beneficiaries of the second CfP:

local authorities, local governments and their institutions, associations of municipalities, development agencies, local business support organizations, economic factors such as SMEs, NGOs, public and private bodies supporting the workforce, vocational and technical training institutions, bodies and organizations for nature protection, public bodies responsible for water management, fire/emergency services, schools, colleges, universities and research centers including vocational and technical training institutions.

5. Selection and award criteria

The evaluation will be carried out in accordance with the procedures set out in the Practical Guide to contract procedures for EU external actions.

6. Maximum rate of European Union financing

The maximum rate of Community co-financing is 85% of eligible expenditure.

7. Indicative time-schedule of calls for proposals

The Call for Proposals is planned to be launched in the 3rd quarter of 2018.

8. Indicative amount of call for proposals
