The Commission adopted on 18 December 2007 the Cross-border Programme between Albania and Montenegro under the IPA Cross-border cooperation Component, for the year 2007.

Albania-Montenegro IPA cross-border programme has been elaborated in accordance with the following regulations:

- Council Regulation (EC) No 1085/2006 of 17 July 2006 establishing an Instrument for Pre-Accession Assistance (IPA);
- Commission Regulation (EC) No 718/2007 of 12 June 2007 implementing Council Regulation (EC) No1085/2006 establishing an Instrument for pre-accession assistance (IPA), amended by Commission Implementing Regulation (EU) No 1292/2011 of 9 December 2011.

The **overall objective** of this programme is to promote cooperation between people, communities and institutions on the bordering areas, aiming at good neighbourly relations, sustainable development, stability and prosperity in the mutual interest of the two countries.

Specific objectives of the Programme include:

- Promote of economic development of the programming area through the economic valorisation of its tourist and cultural potentials
- Support joint initiatives and actions aimed at protecting, promoting and managing sensitive ecosystems and sustainable environmental development
- Encourage citizens cooperation and partnership building across the border
- Strengthen capacities of national and joint structures to manage cross-border programme
- Prepare and disseminate programme information and improve capacities of potential beneficiaries to prepare and implement projects
- Provide technical expertise for external programme evaluations

The rationale of these measures is based on the fact that both eligible areas are compatible in terms of their individual resources and needs, considering also the missed opportunity of cooperation over decades for sharing common values and potentials for economic development and social cohesion. This Programme aim was to capitalise further on existing national initiatives targeting individually development of these regions.

The selected interventions gave a burst toward support economic development with focus on tourism, as tourism is considered to have a great potential for the region as a whole.





Part of the pro-

gramme and projects was focused to support environmental protection measures, awareness and respect of environmental aspects, in particular at Shkodra/Skadar Lake.

The third measure was dedicated to people-

to-people partnership and cooperation as a core element of the Programme seeking to enhance the flow of exchanging experience and communication across the bordering area, intensively facilitate the strengthening of local communities and NGOs and promote social cohesion.





IPA CBC AI-MNE 2007-2013, was a successful experience. The implementation of this programme started on beginning of 2009 and since then, 3 Call for Proposals were successfully organized. The statistics show an increasing number of project submitted form one Call to the other, as programme structures were flexible to adopt and improve the procedures.

For the entire programme period, 138 projects were submitted, covering all 3 measures.

Out of the 3 Calls for Proposals, 24 projects were selected and awarded a grant contract.

At the time when this document is being prepared, 23 projects have already and in different times, finalized their respective activities, while only 1 is still running. This remaining project, extended his contract deadline mainly due to the changes of administrative organization of Albanian territory, which has a huge impact on the project itself..

In total, selected projects are distributed per measure as follows: Measure I— 9 projects Measure II— 8 projects Measure III— 7 projects

STRATEGIC PROJECT

The annual allocations of 2012 and 2013 were dedicated to a Strategic Project commonly identified by both countries benefiting form this programme as an strategic intervention with high cross border effect. This project officially started the implementation of activities on October 2015.

The overall objective of this project is to contribute to the improvement of cross-border infrastructure between Albania and Montenegro, aiming at strengthening the economic and social development in the region.



Specific objective(s) of the project:

The specific objective of this project is to facilitate the movement of persons, vehicles and goods and improve infrastructure in the cross-border transit zone at the BCP Hani i Hotit – Božaj and new joint border crossing point Grabom – Zatrijebačka Cijevna, through:

Upgrading of the border crossing point Hani i Hotit – Božaj including transit zone;

Construction of the new joint border crossing point Grabom (AL side) - Cijevna (MNE side) and road connection with access from Albania.



The 1st CfP for IPA CBC Programme Albania – Montenegro, under 2007 annual allocation, was launched on 29th June 2009, and it was opened for three months, until 29th September 2009. Prior to launching and during the

time when the Call was opened, JTS in close cooperation with other Programme Structures organized the following activities:

1 Info day and Partner Search Forum;

2 trainings for potential applicants;

1 Opening Ceremony and Partner search Forum and

5 Info Sessions.

26 projects were applied under this Call for Proposals.

At the end of the evaluation process, 6 projects were selected to award a grant contract.





Supporting the proposed Trans-boundary Biosphere Reserve of Lake Skadar/Shkodra area through a participatory approach (Best Practice)



The aim of the action is contributing to more successful and efficient environmental and nature conservation policy and action in Albania and Montenegro by increasing the information and professional skills of CSOs and national authorities, and promoting the biosphere reserve concept among them. Selected capacity building operational tools (e.g. trainings courses, exchange visit

to similar experience in other pre accession countries) and capacity building resources (e.g. national/international experts for the collection of data about species and habitats) will be use to this end. Shkodra Lake and its environment have been for a long period the key aspect in the relations between Albania and Montenegro, including the protection of flora and fauna.

This project captured the attention of all interested actors toward the necessity of approving a special status for the area by giving priority to the coexisting of men and nature.

The main output of this project was the publication of the Study on the Biosphere Reserve of Shkodra Lake.

Activities implemented by the project were the following:

- Preparation of a training manuals in both languages;

- Organization of 2 training courses, 1 exchange, 1 technical workshop (each for 3 days) with at least 25 participants;

- Design a monitoring system to assess the impact of the CB activities.

Results Achieved

- The transboundary needed structure, the existing data and the procedures for data collection are clarified;

- An integrated report the designation of the "Biosphere Reserve" in the area of Lake Shkodra/ Skadar is elaborated;

- Training materials available on the national languages (Albanian and Montenegro) are elaborated;



The capacities of NGOs, nature conservation authorities in biosphere reserve, Advocacy techniques and EU biodiversity standards is increased;

Overall access to global resources (knowledge, skills and partnerships) related to Man&Biosphere Program is improved.

This project was a significant incentive for the local/national authorities and environmental NGO's toward approving the status of National Park.



Two Languages - One book (Best Practice)



Overall objective was to Introducing new and long-term communication between the two cultures by means of personal contacts, partnership and cooperation, exchange of information, knowledge and literary translations and contemporary creative work in two languages at cultural and educational institutions, for the purpose of improving cultural and social

and economic situation in the border area and providing conditions for good guality development of civic multi-ethnic communities.

After a long period of absence exchanges for all aspects of life between cross-border communities, this project which was focused on culture cohesion, brought on the opportunity to introduce and exchange literature experiences among writers and public.

In the long-term, the project will inspire and create some of the required conditions for broader cultural participation of citizens from the region, members of minorities in one or the other state (Albanians in Montenegro, Montenegrins in Albania) and presentation of their own, authentic cultural expression.

Cross Border Sculpture Symposium



Public sculpture has the widest impact any work of art can have because of its unavoidable visibility. Even a passer by, uninterested in art will notice an outdoor sculpture merely because it comes his/her way. One of the principal benefits of a sculpture symposium is the production of monumental scale works with a minimum of cost. In the cross border context the symposium is to be the first held between Albanian

and Montenegrin sculptors. Outdoor sculpture is responsible for shaping the artistic landscape of our cities, and such a symposium will enhance the urge for current and future similar collaborations.

Results Achieved

- A change of mentality of artists and the common public toward the correlation art-history.

- Creation and installation of 10 public sculptures per country

- Creation and publication of the sculpture catalogue

- Cultural exchange among artists and communities through figurative art

Community Empowerment a KEY to better environment



The planed action presented in this project will provide an opportunity to common people to use their potential for direct and fast improvement in environment and will allow them to learn about environmental policies in ways that they can engage in meaningful dialogue in processes of policyformulation while they can also monitor the implementation of policies through the monitoring of different projects that will be taking place in their own communities. Participation in local council meetings and engagement with local media and the use of it will be some of the mechanisms that will be used in the project to enable the participation and engagement.

- 10 training modules are offered to the project participants,

Building pathways for tourism cooperation through developing handicraft products



The proposed action aims to make the artisans in both countries enthusiastic and receptive for improvements, to give a boast to the development of their typical products, to realize good sales on the planed events and to generate higher level of sales. It will also help to increase the level of exchange between the craftsmen in the cross border area to capitalize on the experience of each other. Through the action the artisans in Albania and Montenegro will discover the roots of their crafts and learn to make use of cultural designs for the cre-

ation of a variety of new products. The action in both countries will lead to the creation of a sustainable private public partnership between artisans and municipality.

Results Achieved

1. The brand "Zadrima home textile" in Guri i Zi Commune is established.

2. The Albanian and Montenegrin craftsmen are effectively promoting their products (home textiles and trad. dresses) to local and foreign visitors in both sides of the border.

3. Handicrafts museums in Guri i Zi Commune and Museums and Galleries in Podgorica displaying handicraft products are available for visitors.

4. Handicraft products are available in the tourist offer of Capital-City of Podgorica.





MARUBI: a cooperative model for tourist promotion between Shkodra and Ulcinj (Best Practice)

Albania - Montenegro 2007 - 2013




The project was between Shkodra and Ulcinj, historically known for close relations in culture, economy and commerce focused toward a possible development of cultural tourism by creating a dedicated path to connect cities with the photos made by the famous photographer MARUBI, in past years. The project managed to realize a tourist path linking Shkodra to Ul-

cini on the basis of the Marubi's photographs of the places and persons

living in the border region in the past two centuries. Marubi's wide heritage, amounting at around 150.000 photographs, is the common thread of this tourist path, aiming at discovering to tourists the habits and traditions of the border region inhabitants as well as its beautiful natural spots. This path will stimulate tourists to visit the area and let them discover how beautiful and interesting the area is.

Total cost of the Action - € 426,433 Duration - 24 Months

Activities implemented by the project were the following:

- 1. Strategic census of Marubi's patrimony

Results Achieved

1. Identified and collected the undiscovered Marubi patrimony

The project overall impact was estimated by all actors involved as extraordinary important for future perspectives of economic development and culture of the local community. The sustainability of the project outputs is achieved by local authorities itself and MARUBI museum.



Farm-tour: Development of agritourism in Northern Albania andEastern Montenegro(Best Practice)



Overall Objective was to encourage economic development and cultural integration of regions Northern Albania and Southeastern Montenegro, through the development of agro tourism.

The regions selected for this project Kukes, in Albania and Plav and Andrejevicehas in Montenegro do have plenty of resources such as: minerals; water (used for power production); and a rich biodiversity (resulting in a diverse range of agricultural products,

animal production and agro processing). The regions are also rich in heritage, with a strong tradition of local culture and folklore and both are surrounding very beautiful mountains called Prokletije/Bjeshket e Nemuna/Accursed Mountains. The possibilities for agro tourism development in these area are enormous, that is a real option for social and economic development.

This project was specifically addressed to 21 selected farms (11 in Albania and 10 in Montenegro) to improve their business capacities through infrastructure investments, increasing business capacities and technical support.

Total cost of the Action - € 213.125,00

Activities implemented by the project were the following:

1. Study of the development capacity and needs for implementation of agri tourism in 20 pilot farms in Albania and Montenegro.

2. Capacity building for pilot farms in technology improvement, management, hospitality and marketing.

3. Organization of local fairs.

4. Promotion of agri-tourism as a new tourist destination and new tourist fair

Results Achieved

1. New tourist offer increased the number of tourists by 5% in Montenegro project area and 12 % in Albanian area.

2. The number of night accommodation increased also by approximately 10 % in average.

3. Cross border cooperation in tourist sector emerged, from 0 at the beginning of the project, to more then 6 activities in two years.

4. 21 farms were directly supported in all aspects of tourism services and standards.

These farms will further become a model for future and similar initiatives in the region. Family members of these farms whom were directly involved in the project activities were around 120 people.





Development of hydrological and hydraulic study of regulation of Skadar lake and Bojana river water regime - on going



As a very complicated water system, different factors such as the existence of a very big water basin, the big amount of rainfall in period of October-April, and concentration of water downstream the iunction of Buna River with Drini River have made this water basin very prob lematic, and it is expected to be resolved as soon as possible in technical and scien-

Results Achieved

1. Statistical analysis of the design flood events for water system components based on in situ measurements as well as historical data where possible to independently validate the results of the analysis

2. Application of the hydrologic model for the explanation of hydrologic and hydraulic factors in the hydrological cycle and flow oscillations of Buna River and Shkodra Lake water system

3. Bathymetry of the river cross-sections for Drini River and its tributaries and the digital terrain of floodplains for Buna, Drini Rivers and their tributaries in WGS-84 coordinate system

4. Evaluation of the Water Balance of Skadar Lake

5. Regulation of the water regime of Skadar Lake, Bojana river water system to protect cultural monuments situated around this area.

6. Preservation of environment and community for tourist purpose

Performing the Integrated Environmental Management Plan at local level in the Shkodra Lake Ecosytem - EMA-PLAN



This project will foster the creation of a permanent co-operation network among government/local authorities, universities/ research institutions and civil society on both sides of the border, which will offer innovative services through the management of technical and government expertise and the exchange of best practice between the two countries.

Results Achieved

1. Establishment of two strategic documents (Integrated Environmental Management Plan - IEMP) and the Monitoring Programme - MP) for the entire ecosystem of Shkodra Lake

2. Improvement of capacity building in environmental management at and sustainable development at local level of natural resources through the establishment and functioning of monitoring programme and training courses

3. Dissemination of results and raising stakeholder's awareness on environmental management and especially on the conservation of natural patrimonies through activities like training courses, workshops, conferences.

4. improved knowledge's and cooperation among nd with local and central authorities in relation to environmental issues.

Total cost of the Action - € 249,520 Duration - 18 Months






The diagram below presents the distribution of projects per measure.
